**AGREEMENTS FOR CAR RENTAL SERVICES**

This document is drafted as a binding agreement between the hirer and trip car rental Uganda(the vehicle owner) as one way through which all our clients wishing to use our vehicles will comply with **the terms and conditions as below:-**

Any extra day spent with the vehicle shall be assessed and charged accordingly at the return of the vehicle as per the rates above.

The fuel/oil expenses will be met by the hirer of the vehicle during the period of hire.

**In addition to the above terms the hire should take note of the following:-**

1. He /she inspect the vehicle before hire to make sure that it's in proper condition, no liabilities will be accepted after signing of the agreement.
2. No replacement or substitute of any parts or accessories of the vehicles without the knowledge and approval of the company.
3. That the hired vehicles remain the property of the company trip car rental Uganda.
4. That only the authorized driver drives the vehicle and any liability arising out of the authorized driver is met by the hirer.
5. The hirer must take good care of the hired vehicle in matters pertaining good maintainace, by checking engine, oil and other lubricants like water of its security but in case any thing happens due to hirer's negligence of the above he is responsible for repair and replacement.

6. In case of a minor breakdown during the hire of the vehicle, you can make repair of up to **60,000/=** beyond that figure, you are obliged to inform the company before you proceed with the repairs.
7. The hirer shall not use the hired vehicle for any sport activities like racing or motor rally or pull trailer or to sublet the hired vehicle.
8. The hired vehicle shall not be operated in the following circumstances.
9. To transport goods in violation to custom regulations or in any other illegal manner.
10. To propel or tow any vehicle on trail without the consent of the company.
11. By any person driving when not fit to drive e.g. when drunk or under any influence of drugs as per rules and traffic act.
12. The hirer agrees to protect the interest of the owner in case of an accident by obtaining names and addresses of parties involved and the witnesses.

### **Driving Time & Advice**

- a. The vehicle has to stop operations at 07:30pm and should start driving or be on road at 6:00am and above unless it is airport transfer, driving for dinner or shopping, anything happens beyond the mentioned time the client is responsible for whatever that happens on the car.
- b. 30 only the mentioned number of clients on the agreement at period of picking the car should be in until the end of the rented period.
- c. Immediately notify the police if another party's guilt to be ascertained or if any person is injured.
- d. The hirer will comply with the terms and conditions of the insurance policy and the owner any excess in the event of the claim.
- e. Any addition and alternations to these terms and conditions shall be null and void unless agreed upon in writing by both parties

### **INSURANCE**

The operator's rental fleet is insured under, a policy of motor vehicle insurance (**“policy”**) from a company licensed to carry on insurance business in East Africa.

Our insurance policy caters for the vehicle for any damages above USD\$50, head on collusion and theft as well as provide personal life insurance for the passengers. However, the hirer is advised to come with life insurance from home country. Any damages below USD\$50 are negotiated between the hirer and the operator. This insurance does not cover any damage caused by

negligence such as driving under the influence of alcoholism, wheels/trims, cigarette burns, punctures, damage to radio covers badges etc.

Immediately notify the police if another party' guilt is to be ascertained or if any person is injured.

Therefor clients are entitled to get police report and make police statement when he or she gets accident because it is what insurance provider based on to compensate, so when the client does not get this police report is to meet all the expenses.

The excess insurance charged by the operator will vary depending on the type: Rav4 USO 250 Land cruiser Prado USD\$50,

### **IMPORTANT**

The excess charged by the operator in cases of single vehicle rollover is USD\$2000. In this case, we encouraged you to avoid over speeding especially in parks and marram roads.

The hirer will comply with the terms and conditions of the insurance policy and pay the owner any excess in the event the claim

In case of an accident, we give you another car with a driver at a fee of USD USD\$50, per day if you want to continue with your trip. We don't claim.

### **Important;**

The operator is not providing insurance services to the hirer. The operator manages the insurance provided under the policy. The operator reserves them to determine whether or not to claim under the policy in the event of damage of the vehicle, the hirer agrees to immediately contact, and solely deal with the operator.

Overseas use our vehicles are insured for use in only East African Countries. Customers must not attempt to take the vehicle overseas without prior consent from the company or they must pay COMESA insurance at the time of renting the car to cover for the any company damage caused in foreign country and overseas Breakdown insurance is supplied at an additional cost. Details available upon request) fuel vehicles are generally supplied on  $\frac{1}{4}$  to  $\frac{1}{4}$  basis not credit will be given for unused fuel at the end of the rental. Fuel of the car on replacement.

In case of mechanical breakdown we provide replacement of the car within 24hours and we are responsible to fuel to drop the replacement car and then you also provide fuel to return the breakdown case.

Speed limit in National parks is **40km/h** and don't go off track and any client who does it is responsible to pay the **USD\$150**, to Uganda Wild life Authority.

Animals in the National parks have **100%** to the Right of way and clients are to be 100meters

Vehicle must be returned to the agreed drop off location our office during our normal hours of business unless otherwise arranged we can as well drop off our clients to the airport on request.

Returns are not accepted out of these times. Customers that return vehicles late will be charged  $\frac{1}{5}$  daily rate per hour.

**Payment:** We do accept payment by (visa or credit card) on condition you prefer to pay in advance 20days before the arrival date, otherwise if it's by arrival: we prefer payment by cash either in us dollars, Euro, British pounds or Uganda Shillings the company's exchange rate.

The company requires you to notify your final Destination on Arrival.
